On this third anniversary of the passing of Motion M-103 (March 23rd, 2017), Dale Branscombe ponders its implications. The Motion itself (https://tinyurl.com/ gschyb2) and the tendentiously worded petition (petition e-411-Islam) on which it is based (https://tinyurl. com/ychwsf9u), essentially condemn concerns about Islam as "Islamophobia," which deliberately conflates criticism of Islam with discrimination against Muslims. M-103, especially in view of the government's crackdown on alleged hate speech, looks a lot like a blasphemy law through the back door. - M.W.

n March, 2017, the Canadian Parliament passed Motion M-103, a motion designed to reduce or eliminate "Islamophobia." The mind boggles at the realworld implications of this term. From any perspective the motion appears as an obvious encroachment on our greatest cultural treasure - free speech.

All freedoms are derived from the freedom of speech. Only by resolving to guarantee every individual the right to express their views and opinions can we be assured of our own rights.
